Both Institutions have reached agreement on the following areas of cooperation, subject to mutual consent and the availability of sufficient resources:


1. Exchange of faculty in the department of Fashion Design

6. Student exchange for research and study


The terms of such mutual assistance and funding for any specific program and activity shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of a particular program.

Each institution will designate an individual to coordinate this program and all endeavours that may derive from it.


For this purpose, Holy Cross IMT designates Ms. Sreelakshmi of the Department of Fashion Designing and Mount Carmel College designates Ms. Sreeranjini Sagar of the Department of Fashion Design.

This MoU is set in terms of collaboration between both parties and shall commence on the date of latest signature and be in effect for Five years, at which time it shall be reviewed for possible extension. Either party may terminate this Letter by written notification signed by the appropriate official of the institution initiating the notice. However, such notification must be received by the other party at least six months prior to the effective date of termination.
