The terms of cooperation for each specific activity implemented under this MoU for co-operation shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of that activity.

Terms and conditions of the MoU

The two parties hereby agree on the following terms to establish the joint collaborative activities.

- 1. Before the collaborative activities are implemented, both parties shall discuss the problems involved to the satisfaction of each party and enter into specific activity agreement based on the mutually agreed objectives and outcomes of the relationship.
- 2 This MoU shall become effective as of the date of signatures of both parties.
- 3. The MoU shall be applicable for three years from the date of agreement.
- 4. The MoU shall be applicable to exchanging teachers and students on the faculty of Mathematical Sciences for the institutional growth and development of both the parties.
- 5. This MoU is not considered to be a contract creating legal and financial relationships between both the parties. Rather, it is designed to facilitate and develop a genuine and mutually beneficial exchange of human resources /academic relationship, and so forth.
- 6. This MoU should be reviewed after three years to evaluate the progress and the quality of the mutual cooperation. It may be renewed for further three years upon consent of both parties.
- 7. This MoU may be terminated by either party with a minimum of 90 days written notice. Activities in progress at the time of termination shall be permitted to conclude as planned, unless otherwise agreed.
- 8. Both parties subscribe to a policy of equal opportunity and will not discriminate on the basis of race, religion, color, sex, age, national origin or ancestry, marital status, parental status, disability or veteran status.
