This memorandum of understanding (MOU) is entered into on this 27th day of November – two thousand twenty-one (27-11-2021)

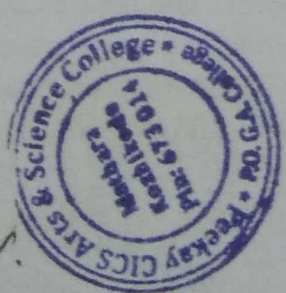

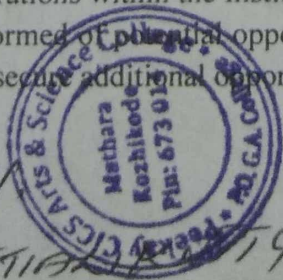
- I. First party is the Department of Psychology, Mount Carmel College, Kothamangalam

- 1.2 First party and Second party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of both parties.

CLAUSE 2 SCOPE OF THE MOU

- 3.1 This agreement will be valid until it is expressly terminated by either party on mutually agreed terms, during which period Department of Psychology, Mount Carmel College, Kothamangalam the first party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of the Second party after termination of this agreement by way of communication, correspondence etc..., shall not be construed as an extension of this MOU.

3.2 Both parties may terminate this MOU upon 30 calendar days notice in writing. In the event of Termination, both parties have to discharge their obligations.


CLAUSE 4 RELATIONSHIP BETWEEN THE PARTIES

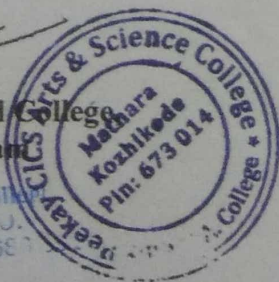


