Field of Cooperation:

1. Principles of Academic Cooperation

The parties wish to facilitate academic and cultural cooperation in one or more of the following areas and agree to work together in good faith with a view to carrying out and fulfilling these aims:

- 1) The exchange of information relating to their activities in teaching and imparting training in the field of academics.
- 2) Organization of periodical joint academic activities such as courses, conferences, seminars, symposia or lectures.
- 3) Facilitation of cultural exchange programs and fostering of relationships across nations.
- 4) Facilitating student and resources exchange and online learning collaborations.
- 5) The exchange of publications, films and other resources of common interest.
- 6) Working together in such other areas of cooperation as may be agreed betweenthe two parties.
- 7) Advice placements and execute training

2. Term and Termination

This MoU is at-will and may be modified by mutual consent of authorized officials from Assumption Hospital, Department of Psychiatry, SulthanBathery, Wayanad, Kerala, 673592and Department of Psychology, Mount Carmel College, Karukadom, Kothamangalam P.O., Ernakulam. This MoU shall remain in force for a period of One year from the date of its signature and seal, and may be terminated by either side by giving a six months' notice to the effect in writing.

3. Non-binding Memorandum with exceptions

- a) This memorandum does not constitute an obligation binding on either party.
- b) This memorandum does not contain all matters upon which the parties are seeking to reach agreement.
- c) This memorandum does not give rise to any contractual relationship between the parties.
- d) This memorandum does not create or imply any relationship between the parties and in particular, the parties expressly agree that this memorandum is not intended to, nor shall, create a partnership, joint venture or agency relationship between the parties.
- e) This memorandum imposes no obligation on any person to enter into any separate writtenagreements.
