Field of Cooperation:

1. Principles of Academic Cooperation

The parties wish to facilitate academic and cultural cooperation in one or more of the following areas and agree to work together in good faith with a view to carrying out and fulfilling these aims:

- 1) The exchange of information relating to their activities in teaching and imparting training in the field of academics.
- 2) Organization of periodical joint academic activities such as courses, conferences, seminars, symposia or lectures.
- 3) Facilitation of cultural exchange programs and fostering of relationships across nations.
- 4) Facilitating student and resources exchange and online learning collaborations.
- 5) The exchange of publications, films and other resources of common interest.
- 6) Working together in such other areas of cooperation as may be agreed between the two parties.
- 7) Advice placements and execute training

2. Term and Termination

This MoU is at-will and may be modified by mutual consent of authorized officials from S H Hospital Paynkulam, Thodupuzha, Idukki and Department of Psychology, Mount Carmel College, Karukadom, Kothamangalam P.O., Ernakulam. This MoU shall remain in force for a period of Three years from the date of its signature and seal, and may be terminated by either side by giving a six months notice to the effect in writing.


3. Non-binding Memorandum with exceptions

- a) This memorandum does not constitute an obligation binding on either party.

- b) This memorandum does not contain all matters upon which the parties are seeking to reach agreement.
- c) This memorandum does not give rise to any contractual relationship between the parties.
- d) This memorandum does not create or imply any relationship between the parties and in particular, the parties expressly agree that this memorandum is not intended to, nor shall, create a partnership, joint venture or agency relationship between the parties.
- e) This memorandum imposes no obligation on any person to enter into any separate written agreements.
