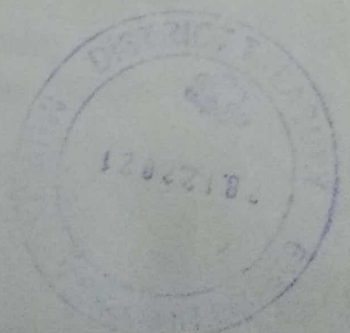
This memorandum of understanding (MOU) is entered into on this 2nd day of March – Two Thousand Twenty-Two (02-03-2022) between

(First party and second party are herein after jointly referred to as "Parties" and individually as "party")

**WHEREAS:**

First party and second party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.

The parties intent to cooperate and focus their efforts on cooperation within area of various placement activities of the department of computer science, in the first party institution.

Both parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.

Signature Resource Hub, Muvattupuzha, the second party is engaged in various services in the fields of training and placements.

**NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:**

**CLAUSE 1 CO-OPERATION**

1.1 Both parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

1.2 The general terms of co-operation shall be governed by this MOU. The parties shall co-operate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the "Definitive

Documents") as any be required to give effect to the actions contemplated in terms of this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the parties on the subject matter thereof.

## **CLAUSE 2 SCOPE OF THE MOU**

2.1 The budding graduates from the first party institution will receive placement training from the second party institution for a mutually accepted period/duration to enhance their skills and knowledge through aptitude training, soft skill development training, and communication skills to make them capable in attaining an esteemed position in reputed companies.

2.2 Both parties understand that all financial arrangements between the parties have to be further negotiated and mutually agreed.

2.3 The financial commitment among the parties will be dealt separately.

## **CLAUSE 3 VALIDITY**

3.1 This agreement will be valid until 1<sup>st</sup> March 2024 unless it is expressly terminated by either party on mutually agreed terms, during which period Department of Computer Science, Mount Carmel College, Karukadom, Kothamangalam, the first Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of the First party after termination of this agreement by way of communication, correspondence etc..., shall not be construed as an extension of this MOU.

3.2 Both parties may terminate this MOU upon 30 calendar days notice in writing. In the event of Termination, both parties have to discharge their obligations.

## **CLAUSE 4 RELATIONSHIP BETWEEN THE PARTIES**

It is expressly agreed that First party and Second party are acting under this MOU as independent contracts, and the relationship established under this MOU shall not be construed as a partnership. Neither party is authorized to use the other party's

name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other party, without the prior written consent of the other party. Neither party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other party, to pledge the other party's credit, or to extend credit on behalf of the other party.
