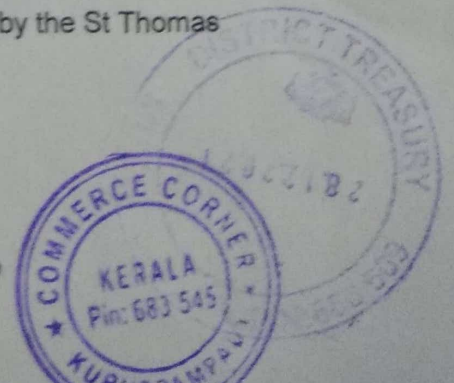
The parties operating under this MOU agree as follows:

- E. **Financial agreement:** Mount Carmel College and commerce corner agree to collect Rs.200 per hour from each student who attend the course.
