Memorandum of Understanding Between G-Tec Computer Education, Kothamangalam and Mount Carmel College, Karukadom

This memorandum of understanding (MOU) is a service agreement between G-Tec Computer Education, Kothamangalam and Mount Carmel College, Karukadom to provide an Add-On Course on 'Tally ERP 9 with GST'.

The parties operating under this MOU agree as follows:

- A. Purpose: G-Tec Computer Education, is an ISO certified organization in the noble field of education in various segments including ICT, Academic programs, ITeS, Corporate trainings, Skilling and vocational trainings including Government projects through quality learning and training centres. G-Tec Computer Education also conducts in house training programs in many reputed colleges.
- B. Mount Carmel College Karukadom, affiliated to MG University situated in the heart of Kothamangalam, it is a minority Christian institution managed by the St Thomas province of the order of Carmalites (O.carm).
- C. Responsibilities: G-Tec Computer Education will be responsible to provide the classes for 'Tally with GST' for a total of 50 hours. The course content and study materials will be issued and the regular assessment of the classes will be done.
- D. Mount Carmel College: On its path will be responsible to promote this course among students and also ensure hosting and pricing of the course, in consultation with G-Tec Computer Education.
- E. **Financial agreement**: Mount Carmel College and G-Tec Computer Education agree to collect Rs.4000 from each student who attends the course.
- F. The revenue sharing structure: 80% of the total collected fees will be given to the authorities of G-Tec Computer Education Centre and G-Tec Computer Education will pay 20% as overhead expense to Mount Carmel College, Karukadom.
